

Euglena gracilis obtained GRAS status in the United States, major ingredient of our food products is certified for sale in the United States as a food materials

euglena Co., Ltd. (headquartered in Minato-ku, Tokyo; Mitsuru Izumo, CEO; "euglena Co.") announces that *Euglena gracilis*, a main ingredient of our food products, had its safety approved in GRAS, a food safety certification system in the United States and attained GRAS status.

GRAS is an abbreviation for Generally Recognized As Safe, an internationally recognized certification system for food safety unique to the US. GRAS status is needed to be acquired to sell food materials in the US.

Euglena gracilis is a kind of microalgae. Among more than 100 kinds of Euglena, particularly Euglena gracilis has a wide range of nutrients; therefore, it is suitable as a raw material for foods and dietary supplements. We cultivate Euglena gracilis in Ishigaki Island, Okinawa Prefecture, Japan, which is named as "Ishigaki Island Euglena." It is used in various products including a core brand of our food products and has been sold in Japan.

This time, we acquired the status of Self-determined GRAS*1, an evaluation system reviewed by a panel of renowned experts in the US regarding "whether it is safe to use in food." By this GRAS status, *Euglena gracilis* has been recognized to be safe as food and has become possible to be sold in the US. The healthcare market in the US is growing. In addition, as an alternative to animal protein, algae are gaining more attentions year after year. We consider that the acquirement of GRAS status under such a circumstance is a great opportunity to provide *Euglena gracilis* to more people.

*¹The GRAS consists of GRAS Affirmation based on FDA evaluation, GRAS notification system (voluntary), and Self-determined GRAS or Self-affirmed GRAS or Self-affirmed GRAS, notification for FDA is not necessary, and evaluations of safety are executed by self-judgment. However, the basic judgment criteria are equivalent to those for acquirement of GRAS Affirmation.

For reaching our goal to realize a sustainable society, we will provide sustainable foods which are safe and secure, and contribute to extending healthy life expectancy, to people worldwide including the US,

<About Ishigaki Island Euglena>

Euglena belongs to a group of algae. Ishigaki Island Euglena, which is cultivated in Ishigaki Island, contains 59 kinds of nutrients (e.g., vitamins, minerals, amino acids, DHA, unsaturated fatty acids such as oleic acid, and paramylon*2; an ingredient unique to Euglena). Also, it does not have cell wall and is a superfood that is characterized by high digestion and absorption rate. In addition, Ishigaki Island Euglena acquires the seaweed certification designed by both ASC (an international certification system for aquatic products cultivated using environmentally and socially responsible methods), and MSC (an international certification system for aquatic products caught by sustainable and environmentally conscious fisheries).

*2Paramylon is an ingredient unique to microalgae *Euglena* and is a polysaccharide composed of glucose molecules linearly linked by β -1,3-glycosidic bonds.
